Section 5. Firefighting measures

Extinguishing media

- Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. - Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
